AGREEMENT FOR THE SEPARATION OF
HUSBAND AND WIFE.

WHEREAS, unfortunate differences and disputes have arisen between the said parties hereto, and they by these presents, do hereby mutually agree to separate with the intent to live apart from each other during the remainder of their natural lives.

AND WHEREAS, the said husband and wife do hereby mutually agree that the consideration moving them hereto, being solely and absolutely happiness, and neither having any property of any kind, except a small amount of personal property, therefore there is no further consideration for this agreement.

NOW THEREFORE, know all men by these presents, that in consideration of the premises, the said wife does hereby release the said husband from all obligations or future support, and she hereby releases and relinquishes unto said husband, his heirs, executors, administrators, and assigns all her rights or claims by way of inheritance in and to any personal property or real property acquired by her said husband hereafter; also all dower rights in any real estate her said husband may acquire hereafter; also any alimony, and said wife does hereby further release and discharge said husband from all obligations or support, except as said husband may from time to time wish or see fit to give her in any amount he wishes to give her. The said wife does hereby further release said husband from all other claims, rights or duties arising out of said marital relation whatsoever.

IT IS FURTHER MUTUALLY AGREED that the said wife is to have custody of the infant child, Martha Smith, born to these parties.

IT IS FURTHER MUTUALLY AGREED that the said husband and wife do hereby agree that each may freely sell or otherwise dispose of his or her own property by gift, deed or will, without in any wise encumbering the rights of the other. And each party is hereby barred from any and all rights or claims by way of dower, curtesy, alimony, inheritance, descent, distribution, or otherwise any rights or claims that may arise out of any property either husband or wife may have or hereafter acquire.
