Taylor, Joe Hannah Taylor, Rosa Elizabeth Taylor, Lola Ora Smith, Lillie Irene Taylor, Washington Lee Taylor, Lida Liza Runion, Henry Toy Taylor, Lela Taylor Copeland, Ina Taylor, Wade H. Taylor, individually and as Executor of of the estate of Henry W. Taylor, Louie Langley, Emily Sue Mitchell, Blanche L. Taylor, Nell L. Gambrell, Dorothy Langley Harper, Walter Claude Langley and John H. Langley, by their attorney in fact, William Homer Langley, and H. D. Copeland, as Executor of the estate of Henry W. Taylor,

in consideration of the sum of Thirty-two Hundred Thirty-five (\$3235.00) DOLLARS, to us in hand paid at and before the sealing of these presents by Robert E. Wade (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, sell and release unto the said Robert E. Wade and his heirs and assigns forever:

All of that parcel or tract of land situate and being in the County of Greenville, South Carolina, lying on the South side of the Buncombe Road, being the hard-surfaced road which leads from Fairview Baptist Church by Locust Hill and intersects with the Greenville-Hendersonville Highway, situate about $3\frac{1}{2}$ miles northwest from the City of Greer, bounded on the north by said Buncome Road, on the east by lands of the estate of Henry W. Taylor, on the south by lands of the Henry W. Taylor estate purchased by Eunice B. Taylor, and on the west by lands of H. G. Copeland and McCauley, and having the following courses and distances according to a plat of the Henry W. Taylor property made by M. O. Owens, Surveyor, dated April 23, 1931, to-wit:

BEGINNING at a stone on the south side of Buncombe Road on corner of H. G. Wade and his Heirs and Assigns, against us and our Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
