L. Wynn's residence to the St. Mark Road, bounded on the North by lands of H. G. Copeland, land of the Henry W. Taylor estate purchased by G. L. Jones and other lands reserved to said estate; on the East by lands of Henry W. Taylor estate, R. L. Wynn and Mrs. Will Few, on the South by lands of Mrs. Will Few, and on the West by lands formerly owned by J. L.
