All that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina.

in the Town of Simpsonville, on the North side of South Pliney Circle, being known and designated as Lot No. 55 on Map of League Estates made by W. J. Riddle, Surveyor, in October, 1941, recorded in the R. M. C. Office for Greenville County, S.C., in Plat Book K at Pages 111-112, and having, according to said map, the following metes and bounds, to-wit:

Beginning at a pin on the North side of South Pliney Circle, at the Southeast corner of Lot No. 54, and running thence with the Northern side of said Circle, N. 66-30 E. 18 feet to pin; thence still with said Circle N. 48 E. 46.7 feet to pin; thence still with said Circle N. 26-25 E. 62.3 feet to pin; thence still with said Circle N. 3-45 E. 56.4 feet to pin; thence still with said Circle N. 12-50 W. 47.9 feet to pin, corner of Lot No. 56; thence with line of Lot No. 56, S. 65-00 W. 134.3 feet to pin, joint corner of Lots Nos. 57 and 54; thence with line of Lot No. 54, S. 19-00 E. 148.7 feet to the beginning corner.
