

## EXECUTOR'S TITLE TO REAL ESTATE.

STATE OF SOUTH CAROLINA,

THIS INDENTURE, made this 23rd day of October in the year of our Lord one thousand nine hundred and Forty-four between C. T. Reid, as Executor of the last Will and Testament of T. H. Reid, late of Campobello in the County of Spartanburg and State of South Carolina, deceased, of the first part, and J. C. Caldwell of the second part:

WITNESSETH, That the said party of the first part, by virtue of the authority to him given in and by the said last Will and Testament, and in consideration of the sum of Two Thousand Eight Hundred Seventy-nine and 80/100 Dollars to him Paid by the said party of the second part (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released and by these Presents does GRANT, BARGAIN, SELL AND RELEASE unto the said party of the second part his Heirs and Assigns forever, ALL THE ESTATE, right, title, interest, property possession, claim and demand whatsoever, both in law and equity, which the said Testator had at the time of his decease; and which the said party of the first part has by virtue of said last Will and Testament of T. H. Reid deceased, of, in and to:

All that certain piece, parcel or lot of land situate, lying and being at Gowansville in Greenville County, South Carolina, containing 7.7 acres, more or less, and being known and designated as Lot No. 8 on the plat of the property of the T. H. Reid Estate, said plat recorded in R. M. C. Office for Greenville County in Vol. M, page 101. Said lot bounded by property of J. C. Caldwell, R. L. Phillips, Lots Nos. 7 and 9 of the T. H. Reid Estate and a side road known as the Phillips Road.

Also, all that certain piece, parcel or tract of land situate, lying and being at Gowansville in Greenville County, South Carolina, containing 106.4 acres, more or less, and being known and designated as Lot No. 15 on plat of the property of the T. H. Reid Estate, recorded in the R. M. C. Office for Greenville County in Vol. M, at page 101. Said lot fronting on Tugaloo Road 1488 feet, more or less, and bounded by Tugaloo Road and property of Mrs. J. L. Caldwell, Lots Nos. 10, 12 and 22 of the T. H. Reid Estate as shown on plat above referred to.
