All that certain lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 23 on Plat of Property of H. G. Stevens made by W. J. Riddle, Surveyor, April, 1941, and recorded in the R. M. C. Office for Greenville County in Plat Book M, page 9, and having the following metes and bounds, according to said Plat:

Beginning at a stake on Paris View Drive, at corner of Lot No. 22, and running thence with line of Lot No. 22 N. 55 W. 200 feet to stake in line of Lot No. 30; thence with rear line of Lots No. 30 and 29 S. 35 W. 70 feet to a stake at corner of Lot No. 24; thence with line of Lot No. 24 S. 55 E. 200 feet to stake on Paris View Drive; and thence with Paris View Drive N. 35 E. 70 feet to beginning corner.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and his heirs and assigns forever.

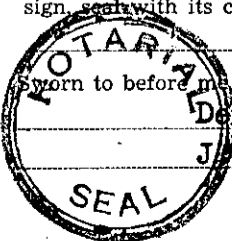
