

TITLE TO REAL ESTATE

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Agnes E. Bruns, her heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the north side of Ashley Avenue, and being known and designated as Lot No. 3 of the property of W. L. Gassaway as shown on plat thereof made by Dalton & Neves, Engrs., and recorded in the R. M. C. Office for Greenville County in Plat Book H, at page 73, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Ashley Avenue at the joint corner of Lots Nos. 3 and 4, which point is approximately 513.3 feet west from the northwest corner of the intersection of Ashley Avenue and North Main Street, and running thence along the joint line of said Lots Nos. 3 and 4, N. 24-38 E. 158.5 feet to an iron pin at the joint rear corner of said lots in the line of property now or formerly belonging to L. O. Patterson; thence along the line of his property, N. 79-25 W. 61.85 feet to an iron pin at the joint rear corner of Lots Nos. 2 and 3 in line of the Patterson property; thence along the joint line of said Lots Nos. 2 and 3, S. 24-38 W. 143.7 feet, more or less, to the joint corner of said lots on the north side of Ashley Avenue; thence along the north side of said Ashley Avenue, S. 65-30 E. 60 feet to the beginning corner.

This lot is shown on the Township Block Book at Sheet No. 178, Block 11, Lot No. 20, and the grantee is to pay taxes for the year 1945.
