possesion of the premises to the Tenant. The Tenant shall have the right to convert said building into a single or more units. Tenant agrees at the expiration of this lease, or the renewal thereof, to restore said building to a six-unit or less structure within sixty days after the termination of the lease, upon written request of the Landlord.

XXI. No rights are conferred upon the Tenant until this lease has been signed by the Landlord, and a copy of the Lease delivered to the Tenant.

This Lease and all covenants and conditions here in contained shall bind and/or inure to the benefit of the parties here to and their respective heirs, executors, and administrators, successors and assigns.

It is understood and agreed that wherever the masculine gender is used in this Lease it shall be extended when necessary to include the feminine or neuter gender and, likewise, the singular number shall be extended when necessary to include the plural.
