BEGINNING at an iron pin on the southwest side of Judson Road, 50 feet east of Valley Street, corner of lot No. 2, and running thence with line of lot No. 2 S. 42-43 W. 200 feet to iron pin in line of lot No. 26; thence with line of lots 26, 25 and 24 S. 53-40 E. 100 feet to iron pin, corner of lot No. 5; thence with line of lot No. 5 N. 42-43 E. 200 feet to iron pin on Judson Road; thence with Judson Road N. 53-40 W. 100 feet to the beginning corner, together with the right to tap grantor's water line on Judson Road for the benefit of each lot.

ALSO, all that piece, parcel or lot of land situate, lying and being in the County and State aforesaid, in Greenville Township, and known as Lot No. 2 on plat recorded in Plat Book F, at page 44, and having the following metes and bounds, to-wit:

BEGINNING at an iron pipe on Judson Road, at corner of Valley Street and Judson Road, and running thence along Judson Road S. 53-40 E. 50 feet to an iron pipe, at corner of lot 3; thence along line of lot 3, S. 42-43 W. 200 feet to iron pipe in line of lot 26; thence along line of lot 26 N. 53-40 W. 50 feet to iron pipe on Valley St.; thence along Valley St. N. 42-43 E. 200 feet to iron pipe at corner of Judson Road and Valley Street, the beginning corner.
