in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Horace Worley and Emma E. Worley, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, just outside the corporate limits of the City of Greenville, on the north side of Montgomery Avenue, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Montgomery Avenue at the corner of lot formerly belonging to W. F. Phillips and running thence N. 33 1/2 W. 80 feet to a stake at the corner of a 20-foot lot now belonging to F. T. McCarter; thence along the line of that lot, N. 56 1/2 E. 32 feet to a stake in line of lot now or formerly belonging to L. B. Raines; thence along the line of that lot, S. 33 1/2 E. 80 feet to a stake on the north side of Montgomery Avenue; thence along the line of said Montgomery Avenue, S. 56 1/2 W. 32 feet to the beginning corner.
