a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of EIGHTEEN HUNDRED FIFTY AND no/100 (\$1850.00) DOLLARS.

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto J. Bruce Chatham and Margaret T. Cheatham, their heirs and assigns:

All those certain pieces, parcels or lots of land situate, lying and being on the west side of North Main Street near the City of Greenville, in the County of Greenville, State of South Carolina, being knowas Lot No. 7 and the south 15.6 feet of Lot No. 8 of Block G, as shown on revised plat of Northgate Subdivision made by R. E. Dalton, Engineer, May, 1939, recorded in the R. M. C. office for Greenville County, S. C., in Plat Book M, page 13, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of North Main Street at joint front corner of Lots No. 6 and 7 of Block G, and running thence with the line of Lot No. 6 in a westerly direction 197.3 feet to an iron pin on the east side of an alley; thence with the east side of said alley in a northerly direction 93.8 feet to an iron pin in the rear line of Lot No. 8, said pin being 15.6 feet north from the joint rear corner of Lots No. 7 and 8, and also being the corner of lot this day conveyed by the grantor to Carl E. Epting and Carolyn W. Epting; thence with said Epting line in an easterly direction 197.3 feet to an iron pin on the west side of North Main Street in the front line of Lot No. 8, said pin being 15.6 feet north from the joint front corner of Lots No. 7 and 8; thence with the west side of North Main Street in a southerly direction 93.8 feet to the beginning corner.

This property is conveyed subject to the following restrictions and reservations:

- (1) No building shall be erected nearer than 50 feet to North Main Street.
- (2) No dwelling shall be erected on said lots costing less than \$6,000.00.
- (3) These lots shall be used for residential purposes only, except this shall not apply as to Section D on the plat above mentioned.
- (4) The property shall not be sold, rented or otherwise disposed of to persons other than of the Caucasian race.
- (5) No obnoxious or offensive trade shall be carried on on the property.
- (6) No building of a temporary structure shall be erected on the property for use as a residence.
- (7) An easement is reserved along the rear line of the lots, two (2) feet in width, for the purpose of placing, sewerage, telephine and electric lines or other utilities, with the right of entry for maintaining and repairing said utilities.

The grantor agrees to pay the 1945 State and County taxes on the above property.
