to it in hand duly paid at and before the sealing and delivery of these presents by the grantee (S) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto J. B. Mauldin, His Heirs and Assigns

Forever:

All that certain piece, parcel or lot of land situate, lying and being on the South-east side of Parkins Mill Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot 2, Block G, Section 4, on plat of East Highlands Estates made by Dalton & Neves, Engineers, January 1941, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book K, at pages 78, 79 and 80 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Parkins Mill Road at joint front corner of Lots 1 and 2 of Block G and running thence with the Southeast side of Parkins Mill Road, S. 31-23 W. 60 feet to an iron pin on the said Road at corner of Lot 3 and running thence with the line of Lot 3, S. 58-37 E. 162.3 feet to an iron pin; thence with the line of Lot 6, N. 33-43 E. 60.1 feet to an iron pin; thence with the line of Lot 1, N. 58-37 W. 164.7 feet to an iron pin on the Southeast side of Parkins Mill Road, the beginning corner.
