KNOW ALL MEN BY THESE PRESENTS, That I ( or we ) C. R. Stone - - - - -  
in consideration of the sum of One Dollar, to me ( or us ) in hand paid, and other valuable consideration at and before sealing and delivering thereof, by the South Carolina Highway Department, receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell, and release, unto the said South Carolina Highway Department, its successors and assigns, a right-of-way for the construction of a section of the State Highway from U. S. 29 to U. S. 276 to - - - - - on Route No. - Belt Line -- State and

County aforesaid, as shown by plans prepared by the State Highway Department, on and over all lands which I ( or we ) may own in whole or in part, for the purpose of locating, constructing, improving, and maintaining the above described highway with the bridges and causeways thereon. Bounded by lands of - - - - - East by Mrs. F. S. Cary, West by Mrs. F. S. Cary and others.  
Show only the Land Owners along the Highway  
Said right-of-way to have a width of - - feet, that is 45' feet on Rt. side of the center of the Highway except where a greater width is necessary for short distances on account of large cuts or fills.

"Special Provisions:" - - - - -  
Together with, all and singular, the rights, members, hereditaments and appurtenances thereunto belonging, or in any wise incident or appertaining. It is agreed that buildings, fences, signs or other obstructions will not be erected by me ( or us ) my heirs, assigns or administrators within the limits of the right-of-way herein conveyed and that such buildings and fences as are now within the limits of the right-of-way herein conveyed will be moved from the right-of-way and restored in as good condition as before moving at the expense of the State Highway Department of the State of South Carolina.

TO HAVE AND TO HOLD, all and singular, the said right-of-way and the rights hereinbefore granted, unto the said South Carolina State Highway Department, its successors and assigns forever.
