SEPARATION AGREEMENT

Husband,

THIS CONTRACT and AGREEMENT of SEPARATION, entered into by and between Alvin Woodrow Henson, and Katie Williams Henson, Wife, WITNESSETH:

For and in consideration of the mutual releases, respective advantages, and other good and valuable considerations, herein provided, the parties hereto enter into the following agreement, to wit:

FIRST: To live separate and apart from each other, and to refrain from interfering one with the other;

SECOND: Each releases the other from all duties and responsibilities whatsoever arising from their marriage contract, marital status, and relationship of husband and wife;

THIRD: Each releases his or her interest in, claim to, dower and curtesy rights, and inheritance, in or to the property, real and personal, of the other, wherever situate, now owned and (or) hereafter acquired, and agrees to execute renunciations in respect thereto at any time or times upon the request of the other, his or her personal representatives, heirs or assigns.

FOURTH: The said wife agrees to keep the two children of the marriage - Clara Kathlene Henson and William Alvin Henson - until the said husband gets his discharge from the United States Navy; upon the husband getting discharged from said navy, the wife agrees to turn said children over to said husband, who shall thereafter have the exclusive care, control and custody of them;

FIFTH: In event either party hereto seeks to obtain a divorce, the other agrees to accept service of all process and papers therein, and to submit to the jurisdiction of the divorce court.

This written instrument contains the entire agreement and contract between the parties, and there is no other understanding between them not embraced herein.
