All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

located on the East side of Cole Road, and designated as Lots #119 and 120 of Plat #4, Camilla Park, which said plat is recorded in the R. M. C. 's Office for Greenville County in Plat Book "M", at page 117, and having according to said plat the following metes and bounds, courses and distances to-wit:

Lot #120:

Beginning at an iron pin at the Southeastern intersection of Cole and County Roads; and running thence with County Road S. 88-47 E. 417.1 feet to an iron pin; thence S. 2-09 E. 100 feet to an iron pin, rear joint corner of Lots #119 and 120; thence along the joint line of said Lots N. 88-48 W. 421.6 feet to an iron pin in the line of Cole Road; thence along the Eastern side of Cole Road N. 0-26 E. 100 feet to an iron pin, the point of beginning.

Lot # 119:

Beginning at an iron pin on the Eastern side of Cole Road, 100 feet from the Southeastern intersection of Cole and County Roads, joint corner of Lots #119 and 120, and running thence with the joint line of said lots S. 88-48 E. 421.6 feet to an iron pin, rear joint corner of said lots; thence S. 2-09 E. 100 feet to an iron pin, rear joint corner of Lots #118 and 119; thence along the joint line of said lots N. 88-50 W. 426.1 feet to an iron pin in the line of Cole Road; thence along the Eastern side of Cole Road N. 0-26 E. 100 feet to an iron pin, the point of beginning.

The above lots are sold subject to existing Right of Way or Easement for power lines.

The within conveyance is made subject to the following restrictions:

1. That the said land shall be used exclusively for residential purposes for white persons only and that the said land shall never be sold, rented, or otherwise disposed of to any person wholly or partly of African descent.
2. That no building shall be erected on said lots costing less than the sum of \$1,000.00.
3. That no building shall be erected nearer the front line of said lot than 30 feet, nor nearer than 10 feet from either side line, or nearer than 5 feet from the rear line of said lot.
4. That the grantor reserves to itself and its successors the right to authorize the placing, maintaining, and repairing of any and all public utilities in the streets without compensation to any lot owner.
5. That no surface closet nor cess pool shall ever be maintained on said land, but only septic tanks or other sanitary sewerage.
6. That no use shall be made of said lot which would constitute a nuisance to the adjoining lot owner.
