I, E. INMAN, Master in and for the County aforesaid, SEND GREETINGS:

WHEREAS, Bessie Q. Wood, in her own right, and as Administratrix of the Estate of I. M. Wood, deceased

on or about the 7th day of July in the year of our Lord nineteen hundred and thirty-seven exhibited her complaint in the Court of Common Pleas, for the County aforesaid, against T. J. Wood, et al

demanding relief as to the real estate described in the complaint, and the cause being at issue, came on to be heard on the 21st day of December ~~xxx~~ 1945 and the 29th day ^{of April 1946} /~~19~~, and such proceedings were had therein as resulted in a Decree

of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for the County aforesaid, to J. Russell Fowler

NOW, THEREFORE, Know All Men by These Presents, That I, E. INMAN, Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$221.00

HAVE GRANTED, conveyed and released, and by these Presents, DO GRANT, convey, and release unto the said

J. Russell Fowler

"All that certain lot of land located near the Southern limits of the Town of Greer, in Chick Springs Township, County and State aforesaid, and known and designated as Lot No. 9 on property of the I. M. Wood Estate as shown on plat made by H. S. Brockman, Surveyor on March 19, 1946, said plat being of record in the R. M. C. Office for Greenville County in Plat Book "P", Page 33, and having the following metes and bounds and courses and distances as shown by said plat, to-wit: BEGINNING at a point in the northern line of Campbell Street, corner of Lot No. 8, and running thence along the line of Lot No. 8, N. 1-33 E. 268.8 feet to a point in line of the Stanly Dillard property; thence along the line of the Dillard property N. 30-13 E. 32 feet to an iron pin; thence continuing along the line of the Dillard property N. 57-20 W. 135 feet to an iron pin at corner of the Mayfield lot; thence along the rear line of the Mayfield lot and Lot No. 7 N. 34-46 E. 140.8 feet; thence S. 68-23 E. 44 feet to an iron pin; thence N. 20-28 E. 93 feet to an iron pin; thence S. 66-24 E. 96 feet to an iron pin; thence S. 30-13 W. 154 feet to an iron pin at corner of lot No. 15; thence along the rear lines of Lots 15 and 14, and along the line of Lot No. 10, S. 0-57 W. 387.8 feet to a point in the northern line of Campbell Street; thence along the line of Campbell Street N. 88-27 W. 70 feet to the point of beginning."
