All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

located on the Eastern side of Mary Street, and known and designated as Lots #124 and 125 of Camilla Park #2, a plat of which is recorded in the R. M. C. 's Office for Greenville County in Plat Book "M" at page 85, and having according to said plat the following metes and bounds, courses and distances to-wit:

Lot #124: Beginning at an iron pin on the Eastern side of Mary Street, 150 feet South of the Southeastern intersection of Mary Street and Frances Avenue, joint corner of Lots #124 and 125 and running thence along the joint line of said lots S. 85-11 E., 216 feet to an iron pin, rear joint corner of said Lots; thence S. 11-02 E. 80.5 feet to an iron pin, rear joint corner of Lots #123 and 124; thence along the joint line of said lots N. 85-11 W., 224.5 feet to an iron pin in the line of Mary Street; thence along the Eastern side of Mary Street N. 4-39 W. 80 feet to an iron pin, the point of beginning.

Lot #125: Beginning at an iron pin on the Eastern side of Mary Street, 70 feet South of the Southeastern intersection of Mary Street and Frances Avenue, joint corner of Lots #125 and 126 and running thence along the joint line of said Lots S. 85-11 E. 207.4 feet to an iron pin, rear joint corner of said lots; thence S. 11-02 E. 80.5 feet to an iron pin, rear joint corner of Lots #124 and 125; thence along the joint line of said lots N. 85-11 W. 216 feet to an iron pin in the line of Mary Street; thence along the Eastern side of Mary Street N. 4-39 W. 80 feet to an iron pin, the point of beginning.

The within conveyance is made subject to the following restrictions:

1. That the said land shall be used exclusively for residential purposes for white persons only and that the said land shall never be sold, rented, or otherwise disposed of to any person wholly or partly of African descent.
2. That no building shall be erected on said lots costing less than the sum of \$1,000.00.
3. That no building shall be erected nearer the front line of said lot than 30 feet, nor nearer than 10 feet from either side line, or nearer than 5 feet from the rear line of said lot.
4. That the grantor reserves to itself and its successors the right to authorize the placing, maintaining, and repairing of any and all public utilities in the streets without compensation to any lot owner:
5. That no surface closet nor cess pool shall ever be maintained on said land, but only septic tanks or other sanitary sewerage.
6. That no use shall be made of said lot which would constitute a nuisance to the adjoining lot owner.
