HAVE GRANTED, conveyed and released, and by these Presents, DO GRANT, convey, and release unto the said

B. M. Lanford

"All those two certain lots of land located near the southern limits of the Town of Greer in Chick Springs Township, County and State aforesaid, and being known and designated as Lot s 10 and 11 of the property of the I. M. Wood Estate, as shown by plat made by H. S. Brockman, Surveyor, March 19, 1946, said plat being of record in the R. M. C. Office for Greenville County in Plat Book "P", Page 33, and having the following metes and bounds and courses and distances, as shown by said plat to-wit:

Lot No. 10: Beginning at a point in the northern line of Campbell Street at corner of Lot No. 11 and running thence along the line of this lot N. 1-33 E. 263.4 feet to a point in line of Lot No. 14; thence along the line of this lot N. 71-21 W. 66.6 feet to a point in line of Lot No. 9; thence along the line of this lot S. 0-57 W. 282.8 feet to a point in the northern line of Campbell Street; thence along the line of said Street S. 88-27 E. 60 feet to the point of beginning.

Lot No. 11: Beginning at a point in the northern line of Campbell Street corner of Lot No. 10 and running thence along the line of Lot No. 10 N. 1-33 E. 263.4 feet to a point in line of Lot No. 14; thence along the line of this lot S. 71-21 E. 62.7 feet to corner of Lot No. 12; thence along the line of this lot S. 1-33 W. 245 feet to a point in the northern line of Campbell Street; thence along the line of said Street N. 88-27 W. 60 feet to the point of beginning."
