All those certain lots, pieces or parcels of land situate, lying and being in said state and county, about three and a quarter miles southeastward from Greenville Court House, between the Augusta Road and Reedy River, south of the Greenville Country Club golf course, having a frontage of Fifty (50) feet, more or less on the north side of Brookside Way, composed of lots numbered 169 - 170, as shown on Dalton & Neves' plat of Marshall Forest, made in October, 1928, and recorded in the office of the Register of Mesne Conveyance for said county in Plat Book "H", on pages 133 and 134, and having such metes and bounds as are shown on said plat; this being a part of the land conveyed to me, as trustee, by Southern Guaranty and Trust Company on August 23rd, 1932, by deed recorded in said office in Book 154, page 229. The title hereby conveyed is subject to the provisions of the "protective covenants" (intended to enable owners of lands in this subdivision to borrow from the Federal Housing Administration) dated October 18, 1941 and recorded in said office in Deed Book 238, page 289, and to the additional covenant_ that no dwelling costing less than Six Thousand and no/100 - (\$6,000) dollars shall be erected on said premises or any portion thereof

It is further agreed that said grantee__ will pay the taxes on said premises for the year 1946 on an assessed valuation of \$ x .

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said grantee__ and his heirs and assigns forever.
