

TITLE TO REAL ESTATE—G. T. 204

KNOW ALL MEN BY THESE PRESENTS, That Defense Housing Co., Inc.,

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of \$3,628.47 and assumption of mortgage referred to below DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee S hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

F. H. Russell and Margaret S. Russell

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina with the buildings and improvements thereon situate, lying and being on Long Hill Street, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #87 according to plat of Augusta Road Hills prepared by Dalton and Neves, Engineers, December, 1940 including revisions made in June and October, 1941 as recorded in the R. M. C. Office, County of Greenville, South Carolina in Plat Book "M" on page 33, having the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Long Hill Street at joint front corner of Lots #87 and #88, said pin being 60 feet West of the point of intersection of Long Hill Street with Cammer Avenue, thence S. 2-56 W. 165 feet to an iron pin at joint rear corner of lots #87 and #88 on the W. J. Iselin property; thence N. 89-20 E. 60.1 feet along the boundary of the W. J. Iselin property to an iron pin at joint rear corner of Lots #86 and #87; thence N. 2-56 E. 161.3 feet to an iron pin at joint front corner of Lots #86 and #87 on the South side of Long Hill Street; thence N. 87-04 W. 60 feet along said street to an iron pin at joint front corner of Lots #87 and #88, the point of beginning.

As a part of the consideration for this conveyance, the Grantees herein expressly assume and agree to pay according to its terms that mortgage and note secured thereby given by Defense Housing Co., Inc., to Liberty Life Insurance Company, dated March 9, 1943 and recorded in the R. M. C. Office, County of Greenville, South Carolina in Mortgage Book 317 on page 181 on which there is due a principal balance of \$3,721.53 with interest from April 1, 1946.

The Grantees herein are to pay the 1946 taxes on the above-described property.

The above-described property is subject to restrictions recorded in the R. M. C. office, County of Greenville, South Carolina in Volume 231 on page 297.
