Furman, Jr., Engineer, March 5, 1923, recorded in R. M. C. office for Greenville County, S. C., in Plat Book F, page 108, of the lands of D. T. Smith, described as follows:

Beginning at a stake on the northern side of Monte Vista Avenue, 400 feet from the eastern side of Smith Street, and running thence with the Avenue in an easterly direction 100 feet to a stake at corner of lot No. 22; thence in a northerly direction parallel with Smith Street with line of lot No. 22 to a stake at corner of lots 19 and 21; thence in a westerly direction parallel with Monte Vista Avenue with line of lot No. 19, 100 feet to a stake at joint corner of lots 17 and 18; the latter belonging to Wilburn Asbury; thence with the Asbury lot, (No. 18) in a southerly direction, parallel with Smith Street, 200 feet to the beginning corner.
