known and designated as lot number 15 of block "G", of the lands of Utopian Development Company, recorded in R.M.C. office for Greenville County in Plat Book "G" at pages 135 and 136, and being more particularly described as follows:

BEGINNING at a point on West Avondale Drive, at the joint corners of lots numbers 14 and 15; thence along west Avondale drive S42-11W 118.1 feet to joint corners of lots numbers 15 and 16 on said Drive; thence S74-40E 186.5 feet to point on alley; thence N15-20E 45 feet along said alley to joint rear corners of lots numbers 14 and 15; thence N84-13W 146.4 feet to the point of beginning.

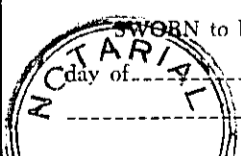

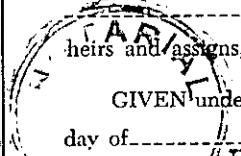
