KNOW ALL MEN BY THESE PRESENTS, That Paris Mountain Caesar's Head Development Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Two Thousand (\$2000.00) DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Mary B. Langille, her Heirs and Assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the North side of Thompson Avenue on Paris Mountain, In Paris Mountain Township, in Greenville County, S. C., and having, according to a Plat made by Pickell & Pickell, Engineers, April 26, 1946, the following metes and bounds, to-wit:

Beginning at an iron pin on the West edge of Thompson Avenue at corner of property now belonging to Langille and running thence with said Thompson Avenue, S. 6-35 W. 210 feet to an iron pin; thence continuing with the curve of Thompson Avenue, S. 49-05 W. 109 feet to an iron pin; thence following said Avenue, N. 63-25 W. 84 feet to an iron pin; thence N. 49-25 W. 203 feet to an iron pin; thence S. 70-15 W. 146 feet to an iron pin; thence S. 44-25 W. 89 feet to an iron pin; thence continuing with Thompson Avenue, S. 6-35 E. 82 feet to a pine; thence leaving Thompson Avenue and running S. 63-00 W. 140 feet to a rock; thence N. 56-45 W. 300 feet to a stone at corner of lands or formerly of Leon Campbell; thence with said Campbell line, N. 34-10 E. 350 feet to a stake; thence continuing with Campbell line, N. 0-15 E. 500 feet to a stake at corner of property of Lions Lair; thence with said property of Lions Lair, N. 10-45 W. 237.5 feet to an iron pin; thence N. 68-30 E. 400 feet to a stake; thence N. 79-30 E. 137 feet to a rock; thence S. 26-15 E. crossing a small stream 352 feet to an iron pin at corner of Langille property; thence with Langille line, S. 26-15 E. 69 feet to an iron pin; thence continuing with Langille line, S. 0-30 W. 573 feet to an iron pin; thence still with Langille line, S. 86-30 E. 83 feet to an iron pin on the West side of Thompson Avenue, the beginning corner.

The Grantee is to pay 1946 taxes on the above property.
