I. M. Brissey, Jr., and Margaret I. Brissey

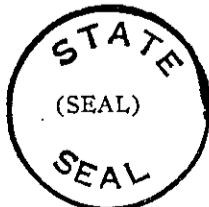
EIGHTH: That subsequently there was elected as President I. M. Brissey, Jr.

NOW, Therefore, I, W. P.
