All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Northern side of McCrary Street, near the City of Greenville, being shown as Lot No. 34 on plat of Elizabeth Heights made by C. M. Furman, Jr. in April 1925, recorded in Plat Book F at Page 298, and described as follows:
