BEGINNING at an iron pin on the Eastern side of Washington Avenue at joint corner of Lots Nos. 20 and 21, and running thence with the joint line of said lots, N. 41-13 E. 565.7 feet to an iron pin; thence N. 47-20 W. 100 feet to an iron pin in line of Lot No. 19; thence with the joint line of Lots Nos. 19 and 20, S. 41-13 W. 527 feet to an iron pin on the Eastern side of Washington Avenue; thence with the Eastern side of Washington Avenue, S. 26-06 E. 108 feet to the beginning corner.
