(the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said

Maggie L. Cooper, her heirs and assigns, forever:

All of those pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, at the Northeastern intersection of Elizabeth Drive and Central Court in the subdivision known as North Sunset Hills, and known and designated as Lots No's 61 and 62 on the plat of said subdivision made by Dalton & Neves, Engineers, July 1941, and recorded in the R. M. C. Office for Greenville County in Plat Book L at page 92, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Elizabeth Drive joint front corner of Lots No's 60 and 61, and running thence along the northern side of Elizabeth Drive S. 62-32 W. 60 feet to an iron pin, joint front corner of Lots No's 61 and 62, thence continuing with the northern side of said Drive S. 60-52 W. 60 feet to an iron pin, thence in a curved line, the chord of which is N. 77-0 W. 49.5 feet to an iron pin on the Eastern side of Central Court, thence along the eastern side of Central Court N. 3-27 W. 99.7 feet to an iron pin on the Southern side of a 5 foot strip reserved for utilities, thence with the South side of said strip reserved for utilities N. 56-45 E. 119.9 feet to an iron pin, joint rear corner of Lots No's 60 and 61, thence along the common line of said lots S. 26-14 E. 132.5 feet to an iron pin on the Northern side of Elizabeth Drive, the beginning corner.

TOGETHER with a one-half interest in the 5-foot utilities alley adjacent to the rear of this lot.

This conveyance is made subject to the restrictive covenants recorded in Deed Book 237, at page 101, in the R. M. C. Office for Greenville County, S. C.

This is a portion of the property conveyed to Knox L. Haynsworth, Trustee, by deed of Riverside Land Company dated June 9, 1941, and recorded in the R. M. C. Office for Greenville County in Deed Book 234, at page 121. Rhoda L. Haynsworth and the grantor herein were successively substituted as Trustee as will appear by reference to the orders of Hon. G. Dewey Oxner, Resident Judge, dated November 19, 1943, and of the Hon. J. Robert Martin, Jr., Resident Judge, dated March 13, 1946, and filed respectively in Judgment Rolls E-9758 and E-10517 in the office of the Clerk of Court for Greenville County, S. C. This conveyance is made by the grantor pursuant to the power and authority granted in the above mentioned order of the Hon. J. Robert Martin, Jr.
