on the Northern side of Stewart Street, near the City of Greenville, being a portion of Block K on Plat of Kanatonah, recorded in the R. M. C. Office for Greenville County in Plat Book F at page 131, and according to Plat of the property of Annie Turner Lindsey made by Dalton and Neves in March, 1946, is described as follows:

BEGINNING at a stake on the Northern side of Stewart Street, 200.5 feet East from Mitchell Street at corner of property of John W.
