KNOW ALL MEN BY THESE PRESENTS, That I, C. F. Haynsworth, Jr., as Trustee

at and before the sealing of these presents by Lowell W. Campbell and Ora L. Campbell

(the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said

Lowell W. Campbell and Ora L. Campbell, Their Heirs and Assigns, Forever:

All of those certain pieces, parcels or tracts of land situate, lying and being in Greenville Township, County of Greenville, State of South Carolina, and being known and designated as Tracts No. 32 and 35 of Riverside Farms as shown by a plat of same prepared by P. H. Foster, August 1907, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of a 30 foot road joint front corner of Tracts No. 32 and 33 and running thence along the North side of said road in a Northwesterly direction 300 feet to an iron pin on said road joint front corner of Tracts No. 32 and 31; thence along the common line of said tracts in a Northeasterly direction 433 feet to an iron pin in the rear line of Tract No. 35; thence along the rear line of Tracts No. 31 and 35 in a Northwesterly direction 20 feet more or less to an iron pin joint rear corner of Tracts No. 35 and 36; thence along the common line of said tracts in a Northeasterly direction 487 feet to an iron pin on the Southwestern side of a 25 foot road, joint front corner of Tracts No. 35 and 36; thence along the Southwestern side of said road in a Southeasterly direction 350 feet to an iron pin joint front corner of Tracts No. 35 and 34; thence along the common line of said last mentioned tracts in a Southwesterly direction 411.5 feet to an iron pin joint rear corner of said tracts which pin is also in the rear line of Tract No. 33; thence along the rear line of Tract No. 33 in a Northwesterly direction 40 feet more or less to an iron pin joint rear corner of Tracts No. 33 and 32; thence along the common line of said last mentioned tracts in a Southwesterly direction 379 feet to an iron pin, the beginning corner.

This is a portion of the property conveyed to Knox L. Haynsworth, Trustee, by deed of Riverside Land Company dated June 9, 1941, and recorded in the R. M. C. Office for Greenville County in Deed Book 234, at page 121. Rhoda L. Haynsworth and the grantor herein were successively substituted as Trustee as will appear by reference to the orders of Hon. G. Dewey Oxner, Resident Judge, dated November 19, 1943, and of the Hon. J. Robert Martin, Jr., Resident Judge, dated March 13, 1946, and filed respectively in Judgment Rolls E-9758 and E-10517 in the Office of the Clerk of Court for Greenville County, S. C. This conveyance is made by the grantor pursuant to the power and authority granted in the above mentioned order of the Hon. J. Robert Martin, Jr.
