Porter, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being on the northeastern side of Bynum Street, near the City of Greenville, County of Greenville, State of South Carolina, being a portion of lot No. 24 of property of Marsmen, Inc., as shown on a plat of said property made by G. A. Ellis, December 1935, recorded in the R. M. C. Office for said Greenville County in Plat Book D, pages 198 and 199, and more fully described as follows:
