to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Talmadge C. Stroud, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being on the Northeastern side of Celand Street, near the City of Greenville, Greenville County, South Carolina, known as lot No. 1 of resubdivision of Central Realty Corporation property according to a plat thereof made by Pickell & Pickell October 17, 1946, recorded in the R. M. C. Office for said Greenville County in Plat Book Q, page 35, and having according to said plat the following metes and bounds, to-wit:

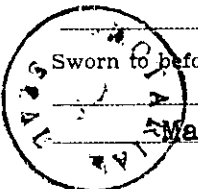
