to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Charles L. Lamb, Jr., his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being on the western side of Clairemont Drive, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 10 on a plat of Shrinewood, property of Central Realty Corporation, made by W. J. Riddle, July 1946, recorded in the R. M. C. Office for Greenville County in Plat Book B, page 86, and having according to said plat, and according to plat made by Pickell & Pickell, October 8, 1946, the following metes and bounds, to-wit:

Beginning at a stake on the western side of said Clairemont Drive at the corner of Lot No. 9, and running thence with the line of that lot, S. 79-15 W. 200 feet to a stake at the rear corner of lot No. 9; thence N. 10-45 W. 25 feet to a stake; thence N. 25-45 W. 23 feet to a stake at the rear corner of lot No. 11; thence along the line of that lot, N. 73-20 E. 198.7 feet to a stake on the western side of Clairemont Drive; thence along the said Clairemont Drive, S. 23-00 E. 50 feet; thence S. 10-45 E. 25 feet to a stake on the western side of Clairemont Drive, the point of beginning.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and his heirs and assigns forever.

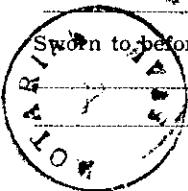
