KNOW ALL MEN BY THESE PRESENTS, That Central Realty Corporation

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Forty-seven Hundred Fifty (\$4,750.00) DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee..... hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto.....

James H. Garner, his heirs and assigns:

All that certain lot of land situate, lying and being on the North side of Durham Street, just outside the city limits of the City of Greenville, Greenville County, South Carolina, being known and designated as Lot No. 3 on plat of property of Central Realty Corporation made by Pickell & Pickell, June 20, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book B, page 199, and having according to said plat the following metes and bounds, to wit:

BEGINNING at a point on the North side of Durham Street which is the joint corner of lots Nos. 3 and 4, and running thence with Durham Street, S. 69-30 W. 60 feet to a point which is the joint corner of lots Nos. 2 and 3; thence along the joint line of said lots Nos. 2 and 3, N. 22-00 W. 136.5 feet to a point which is the joint rear corner of lots Nos. 2 and 3; thence N. 40-26 E. 45.12 feet; thence N. 69-30 E. 30 feet to a point which is the joint rear corner of lots Nos. 3 and 4; thence along the joint line of lots Nos. 3 and 4, S. 22-00 E. 150 feet to joint corner of lots Nos. 3 and 4 on the North side of Durham Street, the point of beginning.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee..... hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee..... hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
