to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto General B. Flynn, his successors

and assigns,

All that piece, parcel or lot of land situate, lying and being on the southeastern side of Virnelle Street, near the City of Greenville, Greenville County, South Carolina, known and designated as lot No. 4 on a plat of resubdivision of Central Realty Corporation property made by Pickell & Pickell, October 17, 1946, recorded in the R. M. C. Office for said Greenville County in Plat Book Q, page 35, and being more fully described as follows:

BEGINNING at a stake on the southeastern side of Virnelle Street at the corner of lot No. 3, which is 135 feet from the intersection of Virnelle Street with Celand Street, and running thence along the said Virnelle Street, N. 54-03 E. 62 feet to a stake at the corner of lot No. 5; thence along the line of that lot, S. 36-05 E. 174.5 feet to a stake at the rear corner of lot No. 5; thence S. 54-03 W. 62 feet to a stake at the rear corner of lot No. 1; thence along the line of lots Nos. 1, 2, and 3, N. 36-05 W. 174.5 feet to the point of beginning.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and his heirs and assigns forever.
