to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Eugene C. Kin Kennon, his heirs assigns:

All that piece, parcel or lot of land situate, lying and being on the southwestern side of Crain Avenue, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 2 of Central Realty Corporation property, according to a plat thereof made by Pickell & Pickell, November 22, 1946, recorded in the R. M. C. Office for said Greenville County in Plat Book P, page 99, having the following metes and bounds, to-wit:

Beginning at a stake on the southwestern side of Crain Avenue, approximately 160 feet from the northwestern intersection of Crain Avenue and Hampton Street, at the corner of lot No. 1 according to said plat, and running thence along the line of said lot, S. 45-15 W. 215.6 feet to a stake at the rear corner of lot No. 1; thence N. 25-30 W. 62 feet to a stake at the rear corner of lot No. 3; thence N. 45-45 E. 215 feet to a stake on the southwestern side of Crain Avenue; thence along the said Crain Avenue, S. 25-30 E. 60 feet to the point of beginning.
