Separation Agreement.

Whereas, we, Virgil D. Wactor, age 19, of said State and County and near the Town of Greer, (now stationed in U.S. Army at Clark Field overseas), and Irene Leora Wactor, of Greer, S.C., said County, (formerly of the State of West Virginia,) age, 24 years were married at Wichta Falls, Texas on January, 14th., 1946, and whereas, we separated and have not lived together as man and wife since May, 25th., 1946 and whereas, we both desire a permanent separation, we do hereby enter into this agreement:

We are separating on friendly terms because of incompatibility in desires, habits, maturity and age etc. Both parties are to be free to act and live their own lives just like they were before marriage and free from all obligations of whatever nature to one another. (Pvt. Virgil D. Wactor's Army Serial Number is 44095826)

In consideration of the Allotment checks and money received by wife after parties here-to were separated in May, 1946 the wife, Irene Leora Wactor, hereby releases her husband, Pvt. Virgil D. Wactor, from any and all support and maintainance of her self in the future (there being no children by this marriage and no prospective child by said marriage) and the wife also relieves and releases her husband from all future Allotment obligations and hereby requests the U.S. Government to cancel all future allotment checks made to her and she has accepted said considerations in lieu of all right, interest and estate that she might have now or in the future to dower in any real estate owned or to be owned by her said husband, and further agrees to freely sign any and all renunciations of dower in and to any and all deeds of land or real estate presented to her by said husband in the future.
