SIXTH: That the number of shares into which the capital stock is divided is **fifty(50)**
of the par value of **One Hundred (\$100.00)** Dollars.

SEVENTH: That, after due notice, a meeting of the subscribers was held on the **10th** day of **February**, 19**47**, at which a majority of all stock in value being present in person or by proxy the following were elected directors:
Jamile J. Francis and Sophie C. Francis

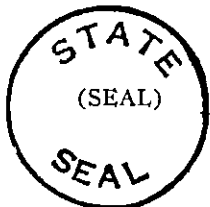
EIGHTH: That subsequently there was elected as President **Jamile J. Francis**
