to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Dewey W. Keith, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being on the northeastern side of Hawthorne Lane, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as lot No. 81 of Langley Heights, according to a plat thereof made by Dalton & Neves, June 1937, recorded in the R.M.C.
