KNOW ALL MEN BY THESE PRESENTS that Universal Zonolite Insulation Co., for and in consideration of the sum of one dollar, receipt of which is hereby acknowledged, does hereby release all its rights, title and interest of any nature whatsoever to the property hereinafter described to H. G. Barton, G. L. Lister, J. D. Bates, W. B. Southerlin, W. F. R. Crain, E. C. McCarrell, J. H. Nelson and M. C. New as Deacons of Tiger Baptist Church.

It is the intention of the Universal Zonolite Insulation Co. in this release to forever release that portion of the property hereinafter described from any and all rights that it acquired as a result of the assignment to Universal Zonolite Co. of a certain lease and agreement dated February 18, 1939 by and between Tiger Baptist Church and Poinsett Insulation Co. of Polk County, North Carolina, the rights and interests of said Poinsett Insulation Co. being subsequently assigned to the Universal Zonolite Insulation Co.

It is the further intent of the Universal Zonolite Insulation Co. to release a portion of the property acquired under the assignment of said lease and that portion of the property hereby released to the above mentioned Deacons of Tiger Baptist Church is more particularly described as follows:

All that piece, parcel and certain tract of land lying and being in Greenville County, South Carolina, and being more particularly described as follows: Beginning at an iron pin on or near the northern side of the Tuguloo Road at the joint corner of property of Boyd McKinney and Tiger Baptist Church and running thence along the line of said McKinney property N. 3 E. 180 feet to a point; thence due west 20 feet to a point near the eastern side of the Access Road leading from Tuguloo Road to property formerly of Poinsett Insulation Company; thence in a line near the eastern side of said Access Road S. 3 W. 180 feet, more or less, to a point on or near the northern side of the Tuguloo Road; thence in a line on or near the northern side of Tuguloo Road N. 80-30 E. 20 feet to the point of beginning.
