Bryant all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina.

about one mile north of Chick Springs, and lying east of St. Mark Road, and being known and designated as Lots Nos. 12, 13 and 14 of a subdivision of the W. B. Williams property, and having in the aggregate the following metes and bounds according to plat and survey by H. L. Dunahoo, C. E., January 21, 1947, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book Q, page 129:

Beginning at a stake on the south side of a county road at corner of Lot No. 11 and running thence with line of Lot No. 11 in a southeasterly direction 150 feet to stake in line of Lot No. 43; thence with line of Lots Nos. 43, 42 and 41, N. 65-30 E. 150 feet to stake at corner of Lot No. 15; thence with line of Lot No. 15 in a Northwesterly direction 150 feet to a stake on the south side of a county road; and thence with said county road S. 62-48 W. 150 feet to the beginning comer.
