to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

John Landrith, and his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being on the Southwestern side of Crain Avenue, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 4 on plat of property of Central Realty Corporation made by Pickell & Pickell, November 22, 1946, recorded in the R. M. C. Office for said Greenville County in Plat Book P, Page 99, and having according to said plat the following metes and bounds, to-wit:
