to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Cullen E. McWhite, his heirs and assigns forever

All that certain piece, parcel or lot of land situate, lying and being on the Southeastern side of Piney Road, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as lot No. 4 of Central Realty Corporation property according to a plat made by W. J. Riddle, July 1946, recorded in the R. M. C. Office for said Greenville County in Plat Book B, page 86, and having according to said plat the following metes and bounds, to wit:

BEGINNING at a stake on the Southeastern side of said Piney Road, 85 feet from the intersection of Piney Road and Clairemont Drive, and running thence with the said Piney Road, S. 73-0 W. 85 feet to a stake at the intersection of Piney Road and Clairemont Drive; thence along the said Clairemont Drive, S. 12-45 E. 231.2 feet to a stake; thence N. 73-0 E. 100.2 feet to a stake at the joint rear corner of lots Nos. 3 and 4; thence along the joint line of said lots Nos. 3 and 4, N. 17-0 W. 231 feet to a stake on the said Piney Road, the point of beginning.
