KNOW ALL MEN BY THESE PRESENTS that I, Elizabeth V. Cox, of the City and County of Greenville, in said State, in consideration of the sum of one dollar to me in hand paid at and before the sealing of these presents by the grantees hereinafter named (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto Myrtle Elizabeth Cox Boney and William Jerry Cox Kitchen (my daughters) an undivided two-thirds interest (that is to say, an undivided one-third interest to each of my said two daughters) in and to the following parcels of land situate, lying and being in said county and state, described respectively as follows:

FIRST: That piece or tract of land containing sixty-five acres, more or less, on the west side of the Augusta Road, about five and one-half miles from the City of Greenville, conveyed to my five sisters and myself by J. W. Gray, Master, on November 12th, 1904, by deed recorded in the office of the Register of Mesne Conveyances for said county in Book "KKK", page 95; being all the land on the west side of said road belonging to my father, the late W. W. Vaughan, to whom it was conveyed by three deeds, as follows: (A) C. C. P. Vaughen's deed of November 3, 1887, recorded in said office in Book "TT", page 492, conveying 251 acres, beginning at a stone 3x o. m. in the Augusta Road near said W. W. Vaughan's residence and running thence N. 35 W. 16.00 chains to a stake 3 x 0. M. on the old line; thence S.  $74\frac{3}{4}$  W. 10.77 ch. to a stone 3 x N. M.; thence S.  $16\frac{1}{2}$  E. 11.83 ch. to a corner in the Paper Mill Road; thence S.  $17\frac{3}{4}$  E. 12.70 ch. to a stake in the Augusta Road and small red oak 3 x N. M.; thence with Augusta Road as the line 17.30 ch. to the beginning corner. (B) Julius H. Heyward's deed of November 28, 1899, recorded in said office in Book "FFF", page 810, conveying 20 acres, beginning at a stone 3 x N. M. on line of Pleasant Walker's land and at corner of Lot No. 3, and running thence N. 2 W. 20.20 ch. with line of Lot No. 3 to stone 3 x 0. M. on an old road; thence along said Old road 10.50 Ch. to stone 3 x N. M., corner Lot No. 1; thence S. 62 W. 15.00 ch. along line of lot No. 1 to stone 3 x 0. M. on line of W. W.
