in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Robert Copeland and Lucille Copeland, their heirs and assigns forever: all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

on the west side of Kelley Avenue, and being known and designated as Lot No. 14, of the property of T. Q. Donaldson, as shown on Plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book A, at page 217, and being more particularly described as follows: to-wit:

Beginning at an iron pin on the west side of Kelley Avenue at the corner of Lot No. 13, and running thence along the line of that lot in a westerly direction 161 feet to an iron pin on the east side of a 20-foot alley; thence along the line of said alley in a northerly direction 50 feet to an iron pin at the rear line of Lot No. 15; thence along the line of said Lot No. 15 in an easterly direction 162 feet to the corner of said lot on the west side of Kelley Avenue; thence along the line of said Kelley Avenue in a southerly direction 50 feet to the beginning corner.
