being known and designated as Lots Nos. 27 and 28 on plat of property of F. B. Massingale made by J. Coke Smith, May 15th 1947, and having the following metes and bounds according to said plat:

BEGINNING at a stake on the south side of Arch Street Extension, at corner of lot No. 29, and running thence with line of Lot No. 29 in a southeasterly direction 226 feet to a stake; thence S. 60-25 W. 120 feet to stake at corner of Lot No. 26; thence in a northwesterly direction with line of Lot No. 26, 227.4 feet to stake on Arch Street Extension; and thence in an easterly direction with Arch Street Extension 120 feet to the beginning corner.
