on McMakin Drive between Belmont Avenue and Dukeland Drive, in the Sans Souci section of Greenville County, about two miles north of the City of Greenville, said lots having the following lines, courses and distances:-

BEGINNING at an iron pin on the southern edge of a five (5) foot sidewalk running along McMakin Drive, said pin being the joint front corner of lots numbered one hundred and seventeen (117) and one hundred and eighteen (118); thence along the western line of lot one hundred and seventeen (117), S. 5-50 E., two hundred and four and four tenths (204.4) feet, to an iron pin, joint rear corner of said lots one hundred and seventeen (117) and one hundred and eighteen (118); thence S. 83-55 W., one hundred (100) feet, to an iron pin joint rear corner of lots one hundred and nineteen (119) and one hundred and twenty (120); thence along the eastern line of lot one hundred and twenty (120), N. 5-50 W., two hundred and four and four tenths (204.4) feet, to an iron pin on the southern edge of said sidewalk running along McMakin Drive, joint front corner of lots one hundred and nineteen (119) and one hundred and twenty (120); thence along the southern edge of said sidewalk, N. 83-55 E., one hundred (100) feet, to an iron pin, the beginning corner, said lots being known and designated as lots numbered one hundred and eighteen (118) and one hundred and nineteen (119) on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "K" at page 92, which plat is hereby referred to and made a part hereof.

Said property is in a restricted district, and is sold subject to the following restrictions, which constitute a part of the consideration therefor, and shall be effective for a period of twenty-five (25) years from the date hereof.

(1) Said property is to be used for residential purposes only.

(2) No residence is to be erected thereon at a cost of less than three thousand dollars (\$3,000.00)

(3) No house is to be erected thereon nearer the southern edge of said sidewalk running along McMakin Drive than twenty (20) feet.

(4) Said property is not to be sold to any person of African descent.
