leased, and by these presents do grant, bargain, sell and release unto the said

All that piece, parcel or lot of land in Greenville Township, Greenville County, State

of South Carolina, located on the West side of what is known as North Park Drive. (The plat shows this lot fronting on an Unnamed Street, connect-  
ing Heston and Griffin Avenues. Heston Avenue has since been changed to  
Kenwood Lane, and Griffin Avenue and the Unnamed Street which are perpen-  
dicular to each other, have been combined to make North Park Drive.) This  
lot is the Northern portion of lot No. 41 of North Park, a plat of which  
is recorded in the R. M. C's Office for Greenville County in Plat Book  
"K" at Pages 48 and 49 and having according to said plat the following  
metes and bounds, courses and distances to-wit:

BEGINNING at an iron pin on the West side of North Park Drive  
(Unnamed Street) which iron pin is 169 feet in a Southerly direction  
from the Southwestern intersection of Kenwood Lane (Heston Avenue) and  
North Park Drive (Unnamed Street), rear joint corner of lots Nos. 40 and  
41; thence along the Western side of North Park Drive (Unnamed Street)  
S. 12-47 W. 50.5 feet to an iron pin in the line of property now or for-  
merly owned by Lenora L. Going; thence along the line of the Going prop-  
erty N. 68-34 W. 68 feet to an iron pin in the line of lot No. 42;  
thence along the joint line of lots Nos. 41 and 42, N. 19-06 E. 50 feet  
to an iron pin, rear joint corner of lots Nos. 39, 40, 41 and 42; thence  
along the rear joint line of lots Nos. 40 and 41, S. 68-34 E. 62.6 feet  
to an iron pin, the point of beginning.

The Grantee by accepting this deed assumes and agrees to pay the  
Mortgage executed by William H. Harper to C. Douglas Wilson & Co., dated  
January 7, 1947, and recorded in said Office in Mortgages Volume 357,  
at Page 119, securing the original sum of \$7, 100.00. This Mortgage has
