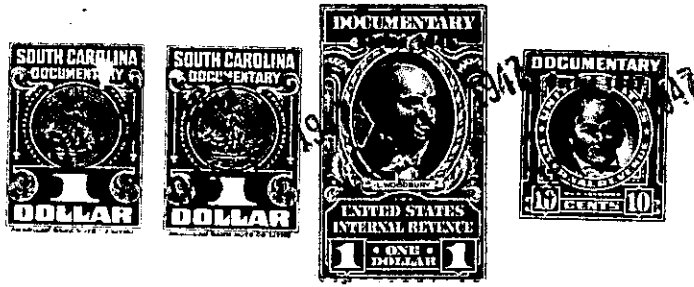

County, State of South Carolina, on the South side of Palmetto Avenue, and being known  
and designated as lots Nos. 1 and 2 of Block "E" on a Plat of Riverside, recorded  
in the R. M. C. Office for Greenville County, in Plat Book "A", pages 322 and 323,  
and having as a whole, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Palmetto Avenue,  
joint corner of lots Nos. 2 and 3, and running thence with line  
of lot No. 3, S. 10-15 W., 125 feet to an iron pin on the  
North side of a fifteen-foot Alley; thence with said Alley,  
N. 79-45 W., 100 feet to an iron pin on the East side of Hill  
Street; thence with Hill Street, N. 10-15 E., 125 feet to an  
iron pin on the South side of Palmetto Avenue; thence with  
Palmetto Avenue, S. 79-45 E., 100 feet to an iron pin, the  
beginning corner. Each of said lots having a frontage of  
50 feet on Palmetto Avenue, and running back in parallel lines  
a distance of 125 feet to a fifteen-foot alley.
