Lot No. 24: BEGINNING at an iron pin on the North side of Ben Street, which iron pin is 599.6 feet West of the Northwestern intersection of Ben Street and McDaniel Avenue, joint corner of lots Nos. 24 and 25; thence along the joint line of said lots DUE MORTH 179 feet to an iron pin, rear joint corner of said lots; thence DUE WEST 68 feet to an iron pin in the line of the property now or formerly owned by Farrell; thence along the line of Farrell property S. 0-38 W. 179 feet to an iron pin in the line of Ben Street; thence along the Morthern side of Ben Street DUE EAST 70 feet to the point of beginning.
