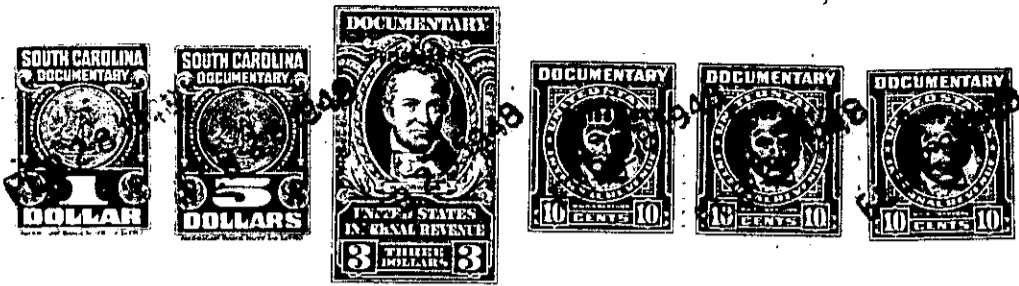

KNOW ALL MEN BY THESE PRESENTS, That I, C. E. Robinson as Trustee  
under B.M. McGee Trust Deed  
in the State aforesaid, in consideration of the sum of Twenty-Six Hundred Fifty & No/100  
Dollars  
to me in hand paid at and before the sealing of these presents  
by G. DeWitt Auld  
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents  
do grant, bargain, sell and release unto the said G. DeWitt Auld

all that piece, parcel or lot of land in Greenville Township, Greenville  
County, State of South Carolina, in the City of Greenville.

Beginning at a stake on the North side of Johnson Street,  
about 208 feet from the East side of Westfield Street at the  
corner of Lot No. 3, on plat made by John M. Cureton, and filed  
in Judgement Roll A-2506, and running thence with line of said  
lot No. 3, N. 10 1/2 E. 82 feet to a stake on an alley; thence  
with said alley S. 89 1/2 W. 5 feet to a stake; thence continuing  
with said alley N. 68-3/4 W. about 41 feet to a stake; thence  
S. 10 1/2 W. 82 feet to a stake on Johnson Street, and thence  
with Johnson Street 45 feet to the beginning corner.

The grantor herein having been appointed successor  
Trustee under B.M. McGee Trust Deed recorded in the R.M.C.  
Office for Greenville County, S.C. in Deed Book Vol. 100,  
page 493, as will appear by reference to certificate of grantor's  
appointment recorded in said office in Deed Book Vol. 214,  
page 76.

This is the same lot of land conveyed to H.P. McGee  
and C.M. McGee, as Trustees, by E. Inman, Master, on  
June 26, 1930, and recorded in the R.M.C. Office for  
Greenville County, S.C. in Vol. 140, page 189.

The grantee agrees to pay 1948 taxes.
